#### DAY 1 MONDAY, JUNE 16

#### **FLIGHT TO SWEDEN**

Today we will transfer to the airport for our overnight flight to **Stockholm, Sweden**. Note: The airport location and airline will be confirmed nine months before departure.

#### DAY 2 TUESDAY, JUNE 17

Welcome to Stockholm! Upon arrival we will be met by our guide and waiting motorcoach and embark on a short sightseeing tour of the city on the way to our hotel. The capital of Sweden is a vibrant city spread over fourteen main islands in the Baltic Sea. Keep your eyes peeled for the impressive City Hall; the Royal Palace; the Baroque Stockholm Cathedral; and the impressive Riddarholm Church, where Swedish kings and queens are laid to rest. After checking in to the Elite Hotel Adlon (or similar), we will enjoy some time to relax before we gather for a wonderful welcome dinner.

#### DAY 3 WEDNESDAY, JUNE 18

#### **STOCKHOLM, SWEDEN**

STOCKHOLM, SWEDEN

Following breakfast we are off to discover Stockholm from the water during a narrated boat cruise. Sit back and relax as we glide under many of the city's bridges and past pleasant neighborhoods while taking in the sights of many city landmarks from the unique perspective of the water. The inner city and green parks will pass us by as we enjoy a real Swedish coffee break called fika, which is coffee with a delicious cinnamon roll. Once back on land, our next stop is the Vasa Museum. The Vasa was an embellished warship that capsized and sank in Stockholm in 1628 on her maiden voyage. The ship was brought up to land and restored in 1961 and inspired one of Scandinavia's most visited museums. After learning about the ship's history from the time it was built to when it was salvaged, our local guide will lead us on a walk through the picturesque back streets of Gamla Stan, Stockholm's charming Old Town. The remainder of the day is yours to explore the city at your leisure. Consider visiting the Skansen open-air market, celebrating the legacy of one of Sweden's most famous bands at the ABBA Museum, or doing some shopping in the Ostermalm district.

### DAY 4 THURSDAY, JUNE 19

**TOFTAHOLM, SWEDEN** Enjoy breakfast at the hotel before we say goodbye to Stockholm and travel through beautiful Smaland, a landscape of natural beauty with a rich history of fishing and hunting that leaves its mark on the Smaland food culture. Marvel at the rolling hills, dense forests, and charming country landscapes before we stop at Bergs Slussar, the berg locks situated in the Gota Canal. During the peak season, thousands of boats pass along the Gota Canal, and the Carl Johan staircase raises and lowers the boats between Lake Roxen and Berg Guest Harbor. A traditional smorgasbord will be available to enjoy on your own. It's the perfect opportunity to savor the flavors of Smaland and be immersed in Swedish culinary traditions! We'll then travel along Sweden's largest lake, Lake Vattern, before venturing onward to the Toftaholm area and the Hotel Toftaholm Herrgard (or similar) for the evening. Take some time to freshen up before we gather for a delicious dinner as a group.

### DAY 5 FRIDAY, JUNE 20

#### **COPENHAGEN, DENMARK**

(Breakfast, Dinner) Today we bid farewell to Sweden and make our way into Denmark. On our way to Copenhagen, we will take the ferry to Helsingor to visit the mighty **Kronborg**. Immortalized by Shakespeare as Hamlet's castle, Kronborg is one of the most important Renaissance castles in northern Europe. It stands as a testament to Denmark's rich history and cultural legacy with its magnificent architecture, historical significance, and enduring connection to literature and the arts. We'll then arrive in **Copenhagen** and embark on a guided city tour of Denmark's capital by both coach and foot. Along the way, our guide will regale us with stories about the dramatic events in Danish history and the flourishing periods favorable to art and beautiful architecture. We'll see incredible sites such as the Round Tower; Rosenborg Castle; the colorful harbor of Nyhavn; Amalienborg, the winter palace of the Danish Royal Family; the Gefion Fountain; and the statue of the Little Mermaid based on Hans Christian Andersen's famous fairytale! We'll then continue on to the stunning Old Danish Stock Exchange, the Carlsberg Glypotek, and the Christiansborg for a walk in the governmental area before we end our tour at the Tivoli Gardens. Enjoy the remainder of the evening at this famous amusement park to enjoy its beautiful scenery, exotic architecture, historic buildings, and lush gardens before we end the day with dinner and our overnight at the **Phoenix Copenhagen** (or similar).

#### **OSLO, NORWAY**

Our adventure today will take us to the bustling market of downtown **Roskilde**, the city of Vikings, kings, and queens. We'll enjoy some time to stroll through the streets of the market town, beginning at Maglekilde, one of Roskilde's natural springs. Then we're off to **Roskilde Cathedral**. It is one of the earliest examples of Gothic architecture in Northern Europe and has been the burial place of Danish royalty since the fifteenth century. Up next is **Roskilde Convent**, originally a manor house, before we walk to **Lutzhofts Old Grocer's Shop** restored to look exactly as it did in the 1920s. Goods typical of the time period are even for sale here! The shop, office, and merchant's yard are all on the tour before we head to Roskilde's harbor for an inside look at the world of the Vikings at the **Viking Ship Museum**. Roskilde developed as the hub of the Viking land and sea trade routes over one thousand years ago, and its Viking history is long and fascinating! The museum focuses on the Vikings' maritime craftsmanship and their impressive ships, with five Viking vessels on display. Upon our return to Copenhagen, we will catch the **night ferry to Oslo** with dinner and our overnight on board.

#### DAY 7 SUNDAY, JUNE 22

Following breakfast we will disembark the ferry and meet our driver and local guide for an **Oslo city tour** including **Vigeland Park** to enjoy the more than 200 extraordinary stone, bronze, and iron sculptures. Then we are off to the **famous ski jump in Holmenkollen** to take in the stunning view over the city before we head into the city center and see **Akershus Fortress**, the **Royal Palace**, the **Town Hall**, and the **Oslo Cathedral**. Up next is the **Norwegian Folk Museum**, one of the world's oldest and largest open-air museums. The 160 buildings on the grounds represent different regions in Norway, different time periods, and differences between social classes. The Gol Stave Church is one of the oldest on display, dating back to the thirteenth century! This afternoon we will check into the **Radisson Blu Plaza Hotel** (or similar) in **Oslo** and enjoy the remainder of the day at our leisure.

#### DAY 8 MONDAY, JUNE 23

After breakfast we will **board the famous Oslo-Bergen railway**, also known as "Bergensbanen." The journey is considered one of the world's most beautiful train rides, taking us through stunning mountain scenery past forests, alpine villages, and the exceptionally beautiful Hardangervidda plateau before arriving in Myrdal. Here we'll switch to a **train on the famous Flåmsbana railway** that is one of the world's steepest lines on normal gauge tracks. The route runs through the rugged and imposing landscape with mountains, waterfalls, and breathtaking views. The end of the line is **Flåm**, where a late lunch awaits. The remainder of the afternoon is yours to explore. After checking in to the **Fretheim Hotel** (or similar), dinner will be enjoyed as a group.

Today is another spectacular day filled with natural beauty. We will begin by boarding a boat for a **cruise through the narrow and beautiful Naeroyfjord**. The fjord is surrounded by steep mountains with snow-covered peaks that soar up to 1,800 meters above sea level. Waterfalls cascade down the mountains and picturesque villages dot the land. This area is one of the most beautiful fjord landscapes in the world, and we get to sail right through it! The cruise will end in Gudvangen where lunch awaits. Then we are off to **Bergen** to check in to the **Radisson Blu Royal Hotel** (or *similar*) for the next two nights and grab dinner on our own.



Lunch will be enjoyed together at a traditional Norwegian farm before we spend the afternoon seeing **Bergehuss Fortress**, the **Viking Hall**, and **St. Mary's Church** before we board the **funicular to Mount Floyen** for an amazing view of Bergen! A delicious group dinner awaits after our exciting day.
